#### Description of Proposed Work: Signage

**HARB Discussion:** The existing shape of the sign will stay. The sign will be altered a little. At the top of the sign it will be cut off to make it more rectangular. They would also like to paint the sign blue. Chris Weaver, the marketing director and Alicia Leach the sales director were at the meeting with Mr. Flickinger. They just moved into the area January 1<sup>st</sup>. They like what they see and they are going to try to promote their business in the town. They also do business nationwide. Mr. Flickinger presented a picture of the proposed sign. They will reuse the poles that are there and install the new piece between the poles in the same location. The business fixes computers; they take data and save it; they set up networks for people. They focus on the cloud.

Mr. Mahan feels the proposed sign is a very modern and very stark contrast to the typical signage around town. He would like the sculpting to remain on the top of the sign. Mr. Flickinger does not have a problem keeping the sculpting. They are very flexible with what HARB would like them to do.

**HARB Recommendation:** P. Long made a motion to accept the sign and the placement of the sign at 101 South Spring Street with the correction to keep the rounded top where it says "offices of"; paint color is fine and the aluminum background is fine. Mr. Mahan seconded the motion. Mr. Flickinger said there is a light outside...at the current time they don't know where it gets controlled, but asked if there was permission to use it if they find out where it goes, which he may since it is pre-existing. HARB members approved the motion for recommendation to Borough Council at their meeting of April 3, 2017.
