HISTORICAL SIGNAGE

An extension has been applied for. Mr. Holderman sent an email to Amy at the Army Corp of Engineers. There is a change on page 3 of the agreement where it states "the installation of a sign shall be completed within 24 months of the issuance of the Corp's permit for the Bellefonte IDA Flood Control Redevelopment Project." This has been changed to "shall be completed by December 31, 2018." This was forwarded on to the Pennsylvania Historical Museum. Mr. Halderman indicated that he believed that Ms. Tooker would be back in late February so perhaps this can be moved along at that time.

If Ms. Tooker does have the language completed for the signage, it will be sent on to PHMC. They will have thirty days to approve it. After that time frame, it will be sent off to get the signage completed. Other than the \$10,000-\$15,000 for the signage, that should be the last major purchase coming from the funds, besides expenditures for minutes and solicitor expenses plus the interest-only payment.
