Compost Facility at Musser Lane

In March 2019, Bellefonte Borough received a \$350,000 grant from DEP for its recycling efforts. The grant will assist the Borough with the purchase of a new leaf collection truck, the addition of an asphalt pad at the composting site at Musser Lane to allow the Borough to place the compost in wind-rows, and to add some security features, including a new entrance gate at Musser Lane. Residents should be aware of the fact these efforts will be underway this summer and to anticipate and account for possible changes to dropping off your brush and grass. Please make sure to look for directional signage if you see any construction or gate installation. If scheduling goes

accordingly, we hope to have the upgrades

completed by the end of September. We do not

anticipate the new leaf collection truck to be delivered until after the season, so you will not see it until the fall of 2020.

Parking Lot D and Metered Parking Downtown

The Borough may finish its parking meter upgrades this summer. This will include the removal of all the parking meters in Parking Lot D (Waffle Shop parking area) and replaced with three parking kiosks. In addition, the Borough is looking into replacing all of the on-street parking meters with new parking meter heads. Once completed, all of the parking meters in downtown will accommodate credit cards. The need to update our parking meters is in part due to the current parking meters being so outdated that parts are not manufactured for them anymore.

Single-family Homes' and Rental Homes' Porches

Borough Projects Scheduled for 2019

Please note Bellefonte Borough's Code Officials will be more diligent this spring and from here on regarding single-family homes' and rental homes' porches not being used for storage. If you are currently using your front porch for storage of material typically found in a garage, basement, or attic, your have thirty (30) days to remove it, otherwise, you will be receiving a letter from Centre Region Code Services mandating you remove the material. Please note we are not talking about porch chairs, etc. This ordinance is directed at 5-10 homes whose porches are used as storage, would be considered unreasonable, and are an eyesore to a neighborhood.

Compost Facility (Musser Lane)

- ⇒ Residents and Commercial Haulers <u>can take</u> to the facility the following: Grass, Brush (3-4 foot lengths), leaves and wood chips.
- ⇒ Residents only can take the following to the facility: Cut up tree (3-4 foot lengths).
- Residents and Commercial Haulers <u>cannot take</u> the following to the facility: railroad ties, concrete, stone.
- ⇒ Residents are allowed to take the following from the facility: pine mulch, regular mulch.
- ⇒ Commercial Haulers <u>must</u> go to the Bellefonte Borough office to pay tipping fees if taking trees to the facility. Tipping fees are: \$50 for single axle; \$75 for double axle.
- \Rightarrow In 2019 there will be designated areas for waste.
- ⇒ The new pad and security locks on the gate will be in place this summer.

FYI: University Area Joint Authority (UAJA) will take trees directly as long as they are not pine trees.

Have You Thought About a Cat House?

If you see this stamped in red on your water bill, please call the Borough Office immediately. Usually, this means your water meter is not working properly and needs maintenance. Please call to avoid receiving a bill that may be overestimated.

Fire Drills - Be Prepared!



Even young children (3 and older) can begin to learn what to do in case of a fire.

- Install at least 1 smoke alarm on every level of your home.
- · Have an escape plan and practice it with your family. This will help you and your family reach safety when it counts. When a fire occurs, there will be no time for planning an escape.
- Draw a floor plan of your home. Discuss with your family 2 ways to exit every room. Make sure everyone knows how to get out and that doors and windows can be easily opened to permit escape. If you live in an apartment building, never use an elevator during a fire. Use the stairs!
- Agree on a meeting place. Choose a spot outside your home near a tree, street corner, or fence where everyone can meet after escaping. Teach your children that the sound of a smoke alarm means to go outside right away to the chosen place.
- Know how to call the fire department. The fire department should be called from outside using a portable phone or from a neighbor's home. Whether the number is 911 or a regular phone number, everyone in the family should know it by heart. Make sure your children know your home address, too. Teach your children that firefighters are friends and never to hide from them.
- Practice, practice, practice. Practice your exit drill at least twice a year. Remember that fire drills are not a race. Get out quickly, but calmly and carefully. Try practicing realistic situations. Pretend that some exits or doorways are blocked or that the lights are out. The more prepared your family is, the better your chances of surviving a fire.

Note: Parents of very young children or children with special needs should have a safety plan that fits their child's needs and abilities. For example, a child who is hard of hearing or deaf may need a smoke alarm with a flashing strobe-light feature. Parents with children younger than 5 years must plan on an adult rescuing them in the case of a house fire; they are too young to be able to reliably rescue themselves.

Bellefonte EMS 2019 annual Ambulance Subscription is available by contacting the EMS office Monday thru Friday 8:30 AM to 4:30 PM at 369 Phoenix Avenue or telephoning (814) 355-2907. These make a great gift for your "hard to buy for" parents or adult children.

The annual subscription covers any patient co-pay or deductible required by your health or auto insurance for emergency ambulance transports. Non-emergency ambulance and Para-transit van transports are not covered under the subscription agreement. For more information contact our office.

Trees

Trees that are between the sidewalk and the street and/or within the right of way are maintained by the property owner. These trees are regulated by Bellefonte Borough. If you would like a tree planted or cut down in this area, contact the Borough office at 355-1501, Ext. 215.

Notes from the Police Department

Phone numbers to access in order to get the proper and quick response needed:

- EMERGENCY-911
- NON-Emergency—1-800-479-0050 (for reporting incidents that are not life threatening in nature). This is the same dispatch center as 911 but this number does not tie up the emergency lines. PLEASE call this number to report an incident that will need police contact that is NOT an emergency.
- ADMINISTRATION-814-353-2320 (for the Bellefonte Borough Police Department administrative office). This is the number to call to leave a message for or speak with an Officer during regular business hours or to ask questions. This number goes to our office and not the dispatch center. After 4:30 p.m. and when the office is closed, this number rings over to the NON-emergency line.

**As a note, there is only one administrative assistant. When she is out of the office, the office MUST remain locked and closed. This is due to the placement of the drug drop-off box in the lobby. Emails and phone messages are monitored and returned as soon as possible.

Police Department Warming Tree: This year more people used the items on our Warming Tree than last year. We are glad to provide these items to those who are in need. However, we do not do this alone. So many talented and generous people kept the tree well-stocked. There were 1) children who worked with their Grandma to put together comfort packs for the homeless and supplied fleece throws, 2) talented women and men who knitted and crocheted so many hats, scarves and gloves, and many individuals who brought in hats, gloves, scarves, socks and throws that they purchased. We planted this tree, but all of you have helped it grow and have taken wonderful care of it. Our residents, business owners and civic organizations have always been supportive of and generous to our Police Department, and for that we are grateful. Bellefonte truly is a kind and caring community in which to live, work and visit. Our Department is "BELLEFONTE PROUD!"

Recreational Fires

In the 2009 International Fire Code (Section 02.1) recreational fires are defined as "an outdoor fire burning materials other than rubbish where the fuel being burned is not contained in an incinerator, outdoor fireplace, portable outdoor fireplace, barbeque grill or barbeque pit and has a total fuel area of 3 feet or less in diameter and 2 feet or less in height for pleasure, religious, ceremonial, cooking, warmth or similar purposes."

This type of fire must be at least 25 feet away from a structure or combustible materials and must not at any point move any closer to the structure than the stated 25 foot distance.

Outdoor fires in a permanent fixture (such as BBQs and gas-fueled fire pits, chimineas) must be at least 10 feet away from a structure or combustible materials. Portable, manufactured outdoor fireplaces must be at least 15 feet away from a structure or combustible materials except for 1- and 2-family dwellings. Borough parking lot by CVS on High Štreet available 24 hours a day, 7 days a week. Items that are to be recycled are: plastic bottles, jugs & jars; glass bottles & jars; steel & aluminum cans; aluminum foil; newspapers, phone books, magazines, catalogs; corrugated cardboard; junk mail; holiday and birthday cards; paper board (such as cereal boxes) and wrapping paper.

Special Collections

Unusually large items and appliances can be disposed of by the Borough refuse collection staff if the pickup is scheduled. A fee is charged for this service and billed separately. There is a limit as to how many can be done each week, so it is on a first-come, first-serve basis. Scheduling can be arranged by calling the Borough office (355-1501) between 8 AM and 4:30 PM, Monday through Friday. A list of the individually priced items is below. If items are not individually priced, the base rate is \$34.80 for the first eight minutes and \$4.35 per minute thereafter. Special collections are only done on Wednesdays, with the exception of weeks that have a holiday. No special collections are done during these weeks. Items that cannot be picked up include steel, batteries, tires, paint, construction materials and radioactive materials.

Annual Bulk Waste Collection

Once a year the Borough holds a bulk waste collection week. It has been the week after the Bellefonte yard sales (May 17 & 18 this year). During this week, Borough customers are permitted to place bulk waste at the **CURB** only for pickup by Borough staff. There will be no charge for this extra pickup service. The bulk waste pickup will follow the same routes and schedules as the regular refuse collection service, with one pickup truck-size load limit per customer. The refuse crew will not make extra trips to an address. Tires, batteries, items too heavy for two people to handle, construction material, paint cans and hazardous waste cannot be picked up during bulk waste collection. Residents are not to use cardboard boxes for items if it is raining or it is calling for rain as it makes it difficult for the refuse crew to pick up the boxes without them falling apart. The Borough reserves the right to not collect if there is too much or it is too heavy.

This year Bulk Waste Collection is May 20-24.

Ash Collection

As of January 1, 2018, ash is being collected with your trash. Please be sure that the ashes are **cold and fully extinguished** before placing them in your trash can. If you have any questions, please call the Borough office at 355-1501.

Leaf Collection

Leaf collection will begin in October. Leaves should be raked to the curb and *not out onto the street*. The crew will attempt to follow the normal refuse schedule for collection.

Reminder

PLEASE remove your refuse container from the front of your residence and out of sight of the thoroughfare that fronts your property by 7PM on your pick-up day. Residents are leaving their container(s) in front of their house and on the sidewalk (safety issue). Pursuant to the Refuse Ordinance, the Borough can levy fines to residents who continue to leave their container out in front of their residence. If you have a specific problem, please contact the Borough at 355-1501.

Collection will begin at 5AM on the Alternate Days. To avoid being missed, refuse **must** be out the night before after 6PM.

Centre County Recycling & Refuse Authority pickup will also follow this schedule. The only exception would be the first day of deer season if it is a Monday.

Brush and grass containers will **not** be collected on the Wednesday during a holiday week. Those Wednesdays include: May 29, July 3, September 4 and November 13.

The composting facility, located at 264 Musser Lane, is open on Saturdays April 6 through November 23. The hours are 8AM-11:45AM. The composting facility is available to all Borough residents for the disposal of leaves, grass or brush only (no concrete, stones, clean fill). A key is available at the Borough office Monday–Friday (a \$10 deposit is required).

Refuse Containers

The refuse crew will not collect trash in any can other than the Borough-issued cans. Extra garbage cans may be purchased for \$60. Your trash billing will reflect however many trash cans

you have x \$57.80 (the cost for refuse pickup of one can). If you do not have a Borough-issued garbage can, please contact the Borough office. When you move, the refuse container is to stay with the property. If your container is missing or stolen, there will be a replacement charge of \$60.00.

All vegetation, except that which is ornamental or edible, shall be maintained at a length of 6" or less.

Brush/Grass Containers

The Borough offers grass/brush containers (for grass, brush, garden waste, and small sticks) for \$60.00. This fee must be paid before we drop off a container to your property. **There will be no additional fee for picking up grass/brush and**

the pick-up day will be Wednesdays beginning April 3 and continuing through November 21. Please contact the Borough if you would like a container. We will take the grass and brush to our compost facility and convert it into compost.

The Borough will continue picking up both the brush and grass containers at the same time. This will allow for more efficiency while also allowing us to continue to recycle the material and meet an ever-increasing demand.

If you do not have a brush container, but do have brush that needs collected, please be sure to bundle it in **four foot** lengths or less and call the Borough office (355-1501) to schedule for a Wednesday pickup. There is not a charge for this service if the amount of brush is reasonable. If there is a large amount, it will be evaluated.

Dial 8-1-1 Before Digging

With homeowners and businesses tackling spring and summer projects, the Borough reminds its residents to always dial 8-1-1 before digging to avoid hitting underground electrical cables and other utility installations.

Homeowners and contractors should contact 8-1-1 three days before beginning a job to be connected to the Pennsylvania One Call Center, which then will notify the appropriate utility company about the work being planned. For more information, go to http://www.pa1call.org/.

Frequently Asked Questions

Do I have to call if I am digging on my own property? Yes, you are required to inform the utilities of any type of work involving the movement of earth with powered equipment.

Who should make the call?

The person who is doing the digging should place the one call notification. If you are a homeowner and you've hired an excavator to do the work, the excavator is required by law to call to have lines located (refer to Section 5 of PA Act 287).

What are PA One Call's hours of operation?

The call center is open 24-hours a day, 7 days a week, every day of the year.

How many days do I have to wait before I can begin digging? State law requires a three (3) business day notice (does not include state holidays or weekends), but not more than ten (10) business days prior to the start of excavation. A business day begins at 12:00:00 a.m. and ends at 11:59:59 p.m. The first lawful start date for your excavation is determined by your scheduled excavation date (the day you plan to start digging), work should not begin prior to your first lawful start date but no later than ten (10) business days from the day of your call.

Water Consumption High?

Here are some tips you can do on your own before contacting the Borough office. If any of these are occurring, you should contact your plumber.

- —Is your toilet running? Is it making a noise?
- -Is there a small drip in a faucet or outside spigot?
- —Don't run water for about 45 minutes. Go to where your meter is located and on top of the meter head there is a little red dial. If it is moving, it is indicating there is still water going through the meter, which usually indicates a water leak. If the red dial is not moving, all is well!
- —Do you hear water running?

Often we get phone calls from residents who think their water meter has gone bad because their usage is so high. Generally speaking, if a meter goes bad, it is going to run slow, not fast.

Park Information

<u>Governor's Park</u>: The pavilions are reserved on a first-come, first-serve basis. Family reunions, birthday celebrations, etc., enjoy the atmosphere of Governor's Park. Rental fees range from 30.00 to \$45.00. For reservations, call the Borough office at 355-1501.

Historical Architectural Review Board (HARB)

Being an owner of a house or property in the Bellefonte Borough Historic District is an investment in both the past and the future. As a caretaker of the property, you are charged with maintaining its historic details and architectural features. The Bellefonte Historic District ordinance was adopted in 1970 to protect the district's distinctive historic character and feel. By encouraging maintenance, sensitive alterations, and appropriate new construction that maintains the feel of the district, design review in a local historic district helps protect and enhance property values.

In an effort to help maintain the character and feel we have come to love, the HARB and its consultant review exterior alterations visible from the public right-of-way. Prior to any project beginning, an application must be submitted to the HARB consultant for review. This year, HARB updated their application in an effort to streamline the process. While much of the process remains unchanged, one change you will notice is a new phased review process for new construction and large projects. This is a three-step process that considers the project through its development and allows developers and the HARB board to work closely together. The other two review levels remain unchanged. Regular maintenance projects where the color, size, texture, shape, and composition of building materials remain unchanged and projects that will result in minimal changes to the property, typically only require administrative approval. However, normal projects which will result in noticeable change to a property will likely require review by the HARB board. HARB also reviews property features including signs, awnings, fences, walls, sheds, decks, pools, sidewalks, driveways, and all other built features of a property. No matter the level of review your proposed project requires, an application always needs to be completed and reviewed prior to work beginning.

A few other changes were implemented in 2019 we want to make you aware of. The first change is that meeting packets are now presented at the meeting via PowerPoint. To aid in public awareness of the agenda items, that PowerPoint and agenda will be posted on our website one week in advance of a meeting. To assist with this, applications are now due by 4:00 p.m. twelve days before a meeting.


The board meets the second and fourth Tuesday of each month at 8:30 a.m. in the Borough building at 236 W. Lamb Street. To be placed on the agenda for an upcoming meeting, applications must be received, with all supplemental information included, by 4:00 p.m. twelve days prior to the meeting. Zoning

With the longer days and warmer weather of spring comes summer projects. Do not forget that many projects to the exterior of your property require a zoning permit. Zoning permits are required for, but not limited to, decks, sheds, fences, swimming pools, and signs. Construction cannot begin until the permit is received. To help with planning, the application fee is \$50 and permits typically take a week to be issued, but may take up to 30 days. Hang this tag on your main water shut-off valve

In the event of an emergency, it might be necessary to turn off the main water valve in your home. It's important that everyone knows where the main water shut-off valve is located. In many homes, it is located near the water meter. If the water meter is not inside, however, the shut off valve is typically located on the water pipe close to where it enters your home or business; possibly in the basement, in a utility closet or crawl space.

PLEASE NOTE: You may want to test the valve to ensure that it is working properly. To test it, find your main shut off valve and close it.

- Gate valve: Gate valves are generally closed by turning the handle clockwise. If the valve does not turn easily, do not force it and consider having the valve repaired so that it does turn easily.
- Ball valve: Generally, closing a ball valve only requires a quarter turn, so that the handle is perpendicular to the water line. In the image below, the valve is open.

Once the main shut-off valve is completely shut off, check sinks and other fixtures to be sure you have found the main valve and that it is working properly. When reopening the valve to turn the water back on, be sure to open it slowly until fully opened.
