# **APPROVAL OF THE MINUTES:**

Mrs. Schneider moved to approve the minutes of the July 28, 2020, HARB meeting.

## **PROJECT REVIEW AND PUBLIC COMMENTS:**

## 227 North Allegheny Street - Porch, Replace Flooring

Mr. and Mrs. Costello were available at the meeting to discuss their porch project. They would like to level the porch, replace flooring and paint. Some pictures were shown to HARB members.

Mr. Costello remarked on the history of the repairs of the porch and they are looking to replace with a composite deck. The existing porch is pulling away for the side and it is split. The roof needs to be raised up a little and the porch deck. The pillars will be repaired as well. Some of the boards are rotted out.

Mr. Costello showed a neighbor's composite porch which was approved by HARB. They are looking at the slate gray color.

Mr. Schneider moved to approve the project as presented. Ms. Long seconded the motion.

Ms. Long amended the motion.

Ms. Long moved to recommend to Council to approve the project as presented using Timbertek flooring in the color slate gray.

Mr. Schneider reminded the applicant that they will need a building permit to do the work. Ms. Costello reiterated the color scheme. The red is just the color for the brick that is already existing; the columns will be the same color but a little brighter; and the trim will be green and includes the handrail and rims at the bottom and tops of the columns.

Ms. Dunne inquired if they were planning on redoing the entire porch facing Allegheny and Burroughs including the two-story porch in the rear of the house facing Burroughs. Mr. Costello stated that they were not. The boards are available in the narrower width and narrow, but the Costello's are choosing the wider width. She clarified the color of the foothill as forest green.

Discussion was held on a HARB member assisting the resident on a project, without recusing themselves from voting on the issue.

# 111 East High Street, Suite 2 – Signage

Mr. Stewart reported on the sign application for 111 East High Street. The building was repainted not too long ago, and they are proposing a 30x40 inch sign. The basic size should be okay as it is the same bracket as used before for the old sign.
