LETTER FORM PUBLIC COMMENT- You may also drop off, in letter form, public comments by putting the letter in our mail slot in our entrance door at 236 West Lamb Street by 3:30PM EST the Monday before the meeting. You must include your name, address and the agenda item.

REQUEST TO SPEAK-PUBLIC COMMENT-To make a comment during a public hearing, a request to speak must be emailed or put in letter form to the above addresses also by 3:30 p.m. the day of the meeting. Include name, address, phone number and the agenda item. A link will be provided to you privately.
