### **OLD BUSINESS:**

**Short Term Rental Ordinance** – At the August 2nd meeting, borough Council approved a professional services agreement with Strategic Consulting Partners to provide facilitator services for the Short-Term Rental Ordinance Stakeholder Meeting. The next step is to organize a date for that meeting. A public hearing will be held in the future as well.

**Complete Streets Policy** – No update at this time.

#### **NEW BUSINESS:**

Updated draft Sign Ordinance was reviewed by Planning Commission. The updated ordinance allows the use of billboards in the Heavy Industrial Zoning District. In the previous ordinance, billboards were not permitted anywhere in the borough. HARB recommended to prohibit the use of feather-style temporary signs from the Historic District and asks council to also consider prohibiting feather-style signs from the entire borough.

It was recognized that billboards are permitted in other municipalities of the Nittany Valley Region. Feather signs were discussed briefly. Political signs were discussed. Digital signs were discussed.

No action was taken by Planning Commission on this ordinance at this time.

**INFORMATION ITEMS:** The Gamble Mill is open. The waterfront project was discussed briefly. Speed control in the Diamond was discussed.

Mr. Gallo moved to adjourn. Mr. Mills seconded the motion. Motion carried. Meeting adjourned at 5:43 p.m.
