Roll call vote was taken with a 6/3 vote in favor of Mr. Bernier.

Gavel was transferred to Mr. Brachbill.

PUBLIC COMMENT (Non-Agenda Items)

Ms. Tosti-Vasey discussed the One Water Plan project. She indicated that this would need to be decided by the next Council meeting. She inquired about a response from the solicitor regarding short term rental properties. Stormwater Engineering Consulting Services was left off tonight's agenda. That appointment will be made at a later date.

Consent Agenda: Nothing actionable presented.

Written Communications:

Ms. Tosti-Vasey moved to conditionally approved the Friday in the Fonte events for 2022. The fees, except for application fee, are waived and more information needs to be obtained regarding control of alcohol sales. Dates will be confirmed for availability once all staff returns. Ms. Cleeton seconded. Motion carried.

Ms. Tosti-Vasey moved to conditionally approve the Chalk the Walk event on July 29, 2022, starting at 4 p.m. on High, Allegheny and parts of downtown Bellefonte. Mr. Bernier seconded. Motion carried.

Mr. Tosti-Vasey moved to conditionally approve the Bellefonte Under the Lights dinner for Friday September 2 and 3, 2022, providing dates are available from 4 p.m. Friday till 8:30 p.m. on Saturday with rain dates of September 9 and 10. If construction commences on the site, the dinner will be moved to the park. Mr. Johnson seconded. Motion carried.

Ms. Tosti-Vasey moved to conditionally approve the Outdoor Expo for October 2, 2022, from 9 a.m. to 7 p.m. conditioned on availability of those dates, pending a plan for control of proposed craft beverages. Fee waived except for application fee. Mr. Johnson seconded. Motion carried.

Ms. Tosti-Vasey moved to approve Small Business Saturday for 2022 and allow for the banner to be hung across High Street from November 15 to January 1, 2023, with the caveat that if another

request comes in the banner only by flown between November 15 and 29, or until the two days prior to the next request for a banner hanging. Mr. Johnson seconded. Motion carried.

Ms. Tosti-Vasey moved to conditionally approve the Winter Market on December 10, 2022, from 9 a.m. to 10 p.m. including set up and take down in conjunction with Victorian Christmas. Mr. Johnson seconded.

Ms. Tosti-Vasey had concerns as last month when the event was held there was some upset regarding the lack of coordination between the Arts and Crafts Fair and Winter Market. At the December 20, 2021, meeting, Council discussed that the discussions would occur, and they would coordinate vendors. Nothing in the request letter states this. Mr. Johnson stated that he was not concerned and recommended conditional approval. Motion carried with one nay Tosi-Vasey.

Mr. Johnson moved to rescind the motion on the parking spaces reinstatement at the Brownstone building, northwest corner of the diamond, from the December 20, 2021, meeting. Ms. Cleeton seconded. Motion carried.

Mr. Johnson moved to reinstate the two spaces that are closest to the YMCA sidewalk as originally designed. Mr. Bernier seconded.

Ms. Tosti-Vasey moved to restrict the two parking spaces to compact cars and to be posted no trucks, SUVs, according to vehicle code. Mr. Johnson seconded. Motion carried. The amended motion then carried with one nay - Tosti-Vasey.

Ms. Cleeton moved to discuss changing the mask mandate for the Borough building. Motion failed as it had no second.

Ms. Tosti-Vasey moved to appoint Mr. Jon Eaton to the Borough Authority. Mr. Johnson moved to appoint Mr. Joe Beigle to the Borough Authority. Council appointed Mr. Jon Eaton to the Authority via 5-4 hand raised vote.

Ms. Tosti-Vasey moved to conditionally appoint Mr. Mark Edwards to the Nittany Valley Joint Planning Commission. Mr. Stewart stated he agreed on the conditional appointment until he checked with staff.

Ms. Cleeton moved to appoint Mr. Doug Johnson to the Nittany Valley Joint Planning Commission. Mr. Bernier seconded. Motion carried.

Mr. Johnson moved to appoint Mr. Dave Lomison to the Borough Planning Commission. Mr. Bernier seconded. Motion carried.

Ms. Tosti-Vasey moved to appoint Mr. Dave Lomison to the Nittany Valley Joint Planning Commission. Mr. Johnson seconded. Motion carried.

Ms. Tosti-Vasey moved to give the nonunion employees the same wage increase as the public works employees including the \$1500 one-time bonus for employees who are in the Defined Benefit Retirement program. Mr. Johnson seconded. Motion carried.
