## XI. COUNCIL COMMENTS FOR THE GOOD OF THE ORDER

Members may offer comments regarding various events and issues within the Borough.
Mayor Johnson reminded the community about the Community Cookout sponsored by Giant for Wednesday, May 24, 2023, 11-2 PM. He again thanked our Police and EMS workers for all they do for our community.

It was also noted that the Bellefonte Area High School Baseball team won the Mountain League Championship for the first time since 2005.

Tosti-Vasey also asked a question regarding the opening of the packet on the public website. It was clarified that a PDF of the Council packet was posted on the Borough website.

Ms. Cleeton commented about the streetlight replacement project in the downtown area. It was clarified that the Borough has been waiting on the delivery of 20 poles for over a year. The electrician for the project reported that the poles are expected to be in sometime in June. The new lights will have new bulbs installed.

Cleeton also asked a question regarding the beveled roof on the Reservoir Building. She noted it is showing signs of rust. It was clarified that the Water Authority would address this issue.

It was clarified that the public could report streetlights that are not working to the Borough for bulb replacement.

Ms. McKean also commented on the safety concerns on S. Potter Street, and she wants to assure residents that the council does hear the public's concerns and that the concerns will be addressed. She also thanked the council for their understanding as she joins the meetings virtually.
