Traffic Stops 70 15 15 Criminal Arrests 3

<u>DEPARTMENT NOTES:</u> (Significant non-routine types of incidents, just a sample of a few, brief description of the incident and outcome)

- * Detective and Chief responded to Janet Weis Children's s Hospital in Danville, PA. A 5 week old from Bellefonte admitted with fractured ribs, fractured skull, broken bones in leg (3). Investigation of child abuse ensued. Child is in critical condition with possible brain damage as well.
- * Reported that demonstrators were to show up at Senator Corman's office. Same group that were arrested at the PA Capitol the day prior. Chief made contact with the protesters on site. They agreed to good behavior terms. No problems at all.
- * A resident on E. Burnside St. had two rather valuable firearms stolen from his parked vehicle. This happened just after 4:00 a.m., vehicle was not locked. Investigation ongoing.
- * Report of a trespass with disorderly conduct. The suspect had left the area with her infant child. Officers located her, while speaking with her she began to "nod" off. She got worse and worse. Known to us for past drug usage, Officer gave her a shot of NARCAN which had no effect. A total of 3 doses were administered, officer bagan CPR. Ambulance was responding from State College. At Hospital she eventually admitted to using Heroin and Fentanyl, and possessed Meth. Her child that was with her was taken into CYS custody. Charges pending Toxicology testing.
- * Officer on foot patrol noticed a male stumble into the Smoker's Express. Officer made contact with the visibly intoxicated male. Officer arranged for a ride home for him.
- * Officer met with a mother and daughter. Mother is in her 60's and wishes to report that her uncle had molested her and her sister over 50 years ago. She is reporting now because she has Huntingdon's Disease and things are coming back to her. Possible investigation.

* Officer was on patrol in Park View Heights. He noticed two juveniles walking. He identified them, warned them of the curfew, had them go home, checked to make sure that they went home and sent out a letter to parents indicating that they needed to respond to this. They did as requested. Next time kids to be cited.
