DEPARTMENT NOTES: (Significant non-routine types of incidents, just a sample of a few, brief description of the incident and outcome)

* After PSU football team beat Auburn, a large group of rowdy students gathered downtown. SCPD requested assistance for the possibility of it turning into a riot. Officer from BPD responded to assist.

* Early morning patrol, officer noticed a person having difficulty making it up S. Spring St. She stopped and gave her a ride to her house. No further action.

* Criminal Mischief, responded to several windows at the old Pizza Hut building broken out with a large rock. Officers were requested to conduct priority patrols in that area for a while.

* Child custody dispute between parents at a school related function. One off Duty BPD officer and an on duty officer dealt with this situation with the child in close proximity. Officers used their best judgment and training to keep the situation from exploding into something much more serious in nature. Kudos to the officers as this is an ongoing dispute amongst the parents and there is a lot of emotion involved.

* Stolen Vehicle. While an officer was dealing with an incident at Beaver Farm, it was discovered that one of the persons involved was in possession of a stolen car out of McKeesport, PA. Person taken into custody as well as the vehicle. Owner responded from Pittsburgh to recover his vehicle the next day.

* Megan's Law violation. Reported by PSP that a person moved into our area who is a life time offender who is required to register his residence changes to the Megan's Law Unit of PSP. After investigation, Det. filed charges and obtained an arrest Warrant for the violator.

* While on foot patrol early in the a.m. officer noticed that the rear hatch to a vehicle was left wide open. This was in a Borough lot. Officer secured the vehicle and attempted to locate the owner. It was way too late to wake him up.
